## Zoom Meeting Minutes Monday, December 13th 2021

**Present:** Allison Snyder, President; Megan Parry; Pat Crandall; Sam Frechette; Mechele Romanchock; Debbie Stephens; Amy Powers; Maria Rhone, Secretary

Also Present: Melanie Miller, Library Director; Rima O'Connor, Technology Coordinator

President Allison Snyder called the meeting to order at 4:01 pm.

- Approval of minutes from November 8<sup>th</sup>, 2021: Megan moved to approve the November minutes, Allison seconded. The minutes were approved.
- 2. Treasurer's Report: Pat moved to approve the November treasurer's report, Megan seconded. The November report was approved. There were no unusual expenses to report. Les recommends adding \$4,000 to the savings account, which will ideally go toward a future building project. Allison moved to approve this amount, Debbie seconded. All were in favor.

## 3. Director's Report from November 2021:

- Melanie reported applying for two new grants: an American Rescue Fund grant and a Penguin Random House small grant.
- Melanie is also working on a DEI (Diversity, Equity, and Inclusion)
  quarterly newsletter.
   Melanie reported
- c. Melanie reported a conversation with a patron regarding occupancy limits. The current policy allows four people in the library at one time. The board revisited the policy and determined that the language could be updated/changed to say, "Occupancy may be limited based on small space of library". Melanie will update the signage at the library.

#### 4 New Business:

Budget:

The budget was reviewed. The 2022 budget will show a deficit in some areas due in part to the suspension of the work study program in 2020 and a need to pay workers out of the budget, a lack of fundraising/donations during the

pandemic, and the overall cost of utilities increasing. Melanie has reduced worker hours and cut costs in other areas as much as possible. Allison called a vote to adopt the budget and all were in favor.

Tax Cap Vote:

Allison moved to override the tax cap for the 2022 budget and Deb seconded. Whereas, the adoptions of the 2022 budget for the Alfred Box of Books Library requires a tax levy increase that exceeds the tax cap imposed by state law as outlined in General Municipal Law Section 3-C adopted in 2011; and Whereas, General Municipal Law Section 3-c expressly permits the library board to override the tax levy limit by a resolution vote of sixty percent of qualified board members; now therefore be it Resolved, that the Board of Trustees of the Alfred Box of Books Library voted and approved unanimously to exceed the tax levy for 2021 on this day, December 13,2021.

#### 5. Old Business:

- Sexual Harassment Prevention Training: Board members and staff (Pat, Maria, Deb, Allison, Rima, and Melanie) completed the interactive portion of the training. All others have already completed the yearly training or will complete it soon with Melanie.
